BYLAW NO. 2021-2

A BYLAW OF THE TOWN OF LAMPMAN, IN THE PROVINCE OF SASKATCHEWAN, TO PROVIDE FOR INCURRING A DEBT

WHEREAS the Council of the Town of Lampman deems it desirable and necessary to incur a debt as set out in Sections 162 and 163 of *The Municipalities Act*, in the amount of One Million, Five Hundred Sixty-Three Thousand, Seventy-Nine (\$1,563,079.91) dollars and 91/100, for the purpose of refinancing the construction of a new lagoon; and

WHEREAS the taxable assessment as shown by the last revised assessment roll thereof, being that for the year 2020 is the sum of Seventy-Three Million, Three Hundred Forty-Three Thousand, Five Hundred Five (\$73,343,505.00) dollars; and

WHEREAS the amount of the existing long term debt of the Town of Lampman is the sum of One Hundred Two Thousand Twenty-Two (\$102,022.12) dollars and 12/100; no part of which, either principal or interest, is in arrears;

NOW, THEREFORE, the Council of the Town of Lampman, in the Province of Saskatchewan, enacts as follows:

- 1. **THAT** pursuant to Sections 162 and 163 of *The Municipalities Act*, the Town of Lampman requires Saskatchewan Municipal Board approval to incur a debt in the amount of One Million, Five Hundred Sixty-Three Thousand Seventy-Nine (\$1,563,079.91) dollars and 91/100; and
- 2. **THAT** the amount of the said debt shall be payable in one hundred seventy-seven (177) monthly installments of Ten Thousand Five Hundred (\$10,500.00) dollars, commencing in year 2021 to 2036 inclusive, with interest at a rate of Two decimal Four percent (2.4%) per annum, payable monthly;
- 3. THE source or sources of money to be used to pay the principal and interest owing under this bylaw will be revenue derived from a fee charged on all water and sewer accounts. In any event, any other available sources of revenue may be used, including annual tax levy.
- 4. **THIS** bylaw shall come into force and take effect on the date of approval being issued by the Saskatchewan Municipal Board, Local Government Committee.
- 5. **THAT** Bylaw No. 2018-7 be hereby repealed.
