A Bylaw to permit the operation of golf carts on the public highways within the limits of the Town of Lampman.

The Council of the Town of Lampman, in the Province of Saskatchewan, enacts as follows:

- It shall be lawful to operate a Golf Cart during the hours between sunrise and onehalf hour after sunset on all the public highways within the limits of the Town of Lampman, with the exception of, that portion of Main Street between Railway Avenue and Third Avenue East.
- Persons operating a Golf Cart on the public highways within the limits of the Town of Lampman must be using the Golf Cart for the sole purpose of transportation to and from the Golf Course, by the direct shortest distance between the Golf Course and where the Golf Cart is stored.
- Persons when operating a Golf Cart on Highway #361 within the Town limits, shall travel on the highway shoulder.
- 4. Golf Carts shall carry a slow moving warning device at the rear, as near to the center as practicable with one side parallel to and not less than 30 centimeters nor more than 120 centimeters from the ground.
- No person shall operate a Golf Cart on the public highways within the limits of the Town of Lampman without a valid drivers licence.
- 6. Any person who contravenes any of the provisions of this Bylaw is quilty of an offence and liable on the summary conviction to a fine of not less than \$25.00 and not more than \$100.00
- This Bylaw shall come into effect upon approval thereof by the Highway Traffic Board.


