

## BYLAW NO. 2016-1

### ***A BYLAW OF THE TOWN OF LAMPMAN, IN THE PROVINCE OF SASKATCHEWAN, TO PROVIDE FOR THE LICENSING OF OPERATORS OF TRAILER PARKS OR CAMPS, AND THE LICENSING OF TRAILERS***

---

The Council of the Town of Lampman, in the Province of Saskatchewan, enacts as follows:

#### **Short Title:**

1. This Bylaw may be cited as *The Lampman Trailer Licensing Bylaw*.

#### **Definitions**

2. The following terms shall have the following meaning in the Bylaw unless otherwise hereinafter specifically defined:
  - (a) **“Trailer”** shall be defined as a camp trailer, mobile home, portable shack or doghouse or any other structure that is not permanently mounted on its own wheels and used as living quarters.
  - (b) **“Trailer Park or camp”** shall mean any parcel of land used as a parking area for trailer or trailers as described in 2(a).
3. No person shall operate a trailer park or camp within the boundaries of the municipality without first obtaining a license from the administrator.
  - (a) All trailers must be connected to a sewer system approved by Saskatchewan Health and inspected by a public health officer; whether it be connected to a septic tank or the Town's sanitary sewer system.
4. The license fee shall be payable in advance on a monthly basis and shall expire on December 31 next following the date of issue.
5. The license fee shall be one hundred dollars (\$100.00) per unit per month.
6. The operator of a trailer park or camp licensed under this Bylaw is hereby required to remit the prescribed fee per unit to the Town of Lampman. In addition, the operator of a trailer park or camp must maintain a record of all units within the park or camp.
7. All fees collected under Section 4 of this Bylaw shall be turned over to the administrator of the municipality by the 5<sup>th</sup> day of each month. Fees not remitted by December 31<sup>st</sup> in any year shall be added to the tax card of the owner of the trailer park, and form part of their tax arrears.

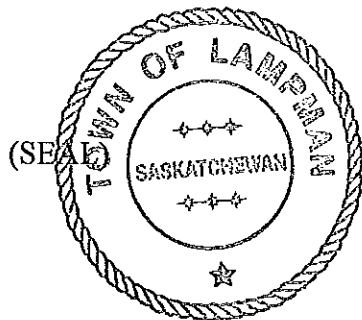

8. It shall be the responsibility of the operator of a trailer park or camp licensed under this Bylaw to register each trailer or portable shack located therein with the Town of Lampman.
9. The record mentioned in Section 6 shall be open to inspection at all times.
10. Sections 4 to 7 and Section 9 of this Bylaw shall apply mutatis mutandis to every owner or occupant of property who permits two or more trailers or portable shacks to be located thereon.
11. A person who contravenes any of the provisions of this Bylaw is guilty of an offence and liable on summary conviction to the penalties provided in the General Penalty Bylaw of this municipality.
12. Bylaw No. 2010-10 is hereby repealed.
13. This Bylaw shall come into force on final passing thereof.




